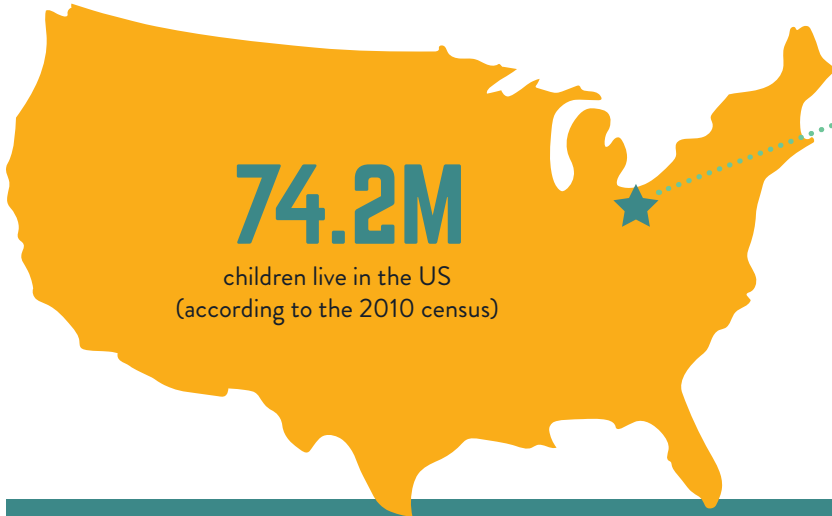

**ADOPTING CHILDREN FROM FOSTER CARE CAN BE VIRTUALLY — free! —**

Many agencies **do not charge for the services** they provide to families who are adopting a child from foster care. In addition, a growing number of companies and government agencies offer **adoption assistance** as part of their employee benefits packages, including time off for maternity/paternity leave, financial incentives, and other benefits. Congress has also made **federal tax credits** available for foster care adoptions to help offset required fees, court costs, and legal and travel expenses. In 2012, the maximum federal tax credit for qualifying expenses was \$12,170.

*These types of benefits enable more families to adopt children from foster care into their homes.*



Congress has streamlined the foster care adoption process through the enactment of the **Adoption and Safe Families Act of 1997**. This law stipulates that children in foster care, who cannot be reunited with their birth parents, are freed for adoption and placed with permanent families as *quickly as possible*.

**THERE ARE MANY FEDERAL AND STATE SUBSIDIES AVAILABLE FOR FOSTER CHILDREN AFTER ADOPTION THAT CAN INCLUDE CASH SUBSIDIES, MEDICAL ASSISTANCE, AND SOCIAL SERVICES.**
